# NEW DRAFT GUIDE ON PRACTICAL METHODS FOR IMPLEMENTING THE IMO OPRC CONVENTION AND THE OPRC-HNS PROTOCOL

For more than 20 years, the OPRC Convention has been an important tool for the improvement of oil spill preparedness and response throughout the world and currently has 112 Contracting Parties. The OPRC-HNS Protocol currently has 39 Contracting Parties.

However, there remain parts of the world in which many countries have still not ratified the Convention or its Protocol, or have ratified the Convention but it has not been implemented.

This week IMO's Sub-Committee on Pollution Prevention and Response (PPR) meets in London and is being asked to review and approve the new draft guidelines developed by the IMO correspondence group led by Norway. Subject to PPR approval the final draft will be submitted to the next meeting of the Marine Environment Protection Committee (MEPC) for adoption.

The purpose of the Guidelines is to help Governments to successfully adopt and implement the OPRC Convention and OPRC-HNS Protocol within their national legislation.

Publication of the new Guidelines will be an important step in assisting progress being made towards the worldwide observance of rules designed to enhance preparedness for response to environmentally damaging oil and chemical spill events.

## DISASTER DIPLOMACY: OIL SPILL, RADIATION LEAK AND EPIDEMIC WILL BE SIMULATED BY RESEARCHERS TO TEST RUSSIA-NORWAY RELATIONS



February 7 - A two-year investigation into disasters around Svalbard kicked off Jan. 19-20 with a planning meeting at The University Centre in Svalbard. This project's focus is whether or not dealing with disasters – before, during and after – can be used more in

the Arctic to foster peaceful links between Norway and Russia. Conducting the study in Svalbard aims to make the research useful for those living in the archipelago.

Nine researchers from London, Moscow, and around Norway decided on specific scenarios, the data collection methods, and how to work with policy makers and practitioners. Three disaster possibilities were selected to see how Norway-Russia relations might be helped, be hindered, or be unaffected. One scenario is oil spill emergency management, building on the extensive work, training, and experience already available. Ice People / Read more

## AUSTRALIA: OIL FIELDS CLASH WITH NATURAL WONDER IN THE GREAT AUSTRALIAN BIGHT

February 10 - The Great Australian Bight is one of the most pristine marine ecosystems on the planet. Home to orcas, seals, dolphins and southern right whales, much of the biodiversity found here exists nowhere else on earth.

The Great Southern Reef is estimated to generate \$10 billion every year from fishing and tourism for the Australian economy.

## CANADA: BUILDING LOCAL CAPACITY FOR OIL SPILL MONITORING AND RESPONSE IN NUNAVUT



February 15 -Changing environmental conditions and advancements in engineering and technology have led to more ship traffic in Canada's Arctic. This change comes with exciting opportunities, but also increased risk. One potential risk is accidental spills of oil and other harmful substances.

Creating a sustainable future for ocean transportation is vital to supporting Canada's economic and environmental interests. With funding from Irving Shipbuilding, the Enhanced Capacity for Oil Spill Situational Awareness and Response (ECOSAR) project team is developing practical, community-based solutions for these issues.

One goal of the project is to develop a program that uses satellite data to detect when an oil spill occurs. A second focus is to develop and deliver an oil spill response training program for Nunavut residents. Ships for Canada / Read more

#### FRANCE: ACTIVITY REPORT FROM CEDRE FOR JANUARY 2019

February 13 - January was a relatively calm month for Cedre's duty officers. The emergency response team pursued actions in the Var area where two experts were mobilised to monitor clean-up operations. The Seine-Aval Public Interest Group (Rouen) reported a spill, believed to be oil, in the Seine River. We received an enquiry from MRCC Corsen on the choice of product for the MOTHY slick drift forecast form. MRCC Corsen also requested an analysis and recommendations following a pollution incident near Belle-Île. We received an enquiry from the State Action at Sea division (AEM) for French Polynesia, followed by CEPPOL, as to the risks related to gas canisters drifting at sea after rising to the surface from a scuttled ship. The canisters were found to contain methyl bromide (UN 1062). An ICE test was organised by the Swedish centre in Stockholm. A member of the IMO Maritime Safety Committee requested data on the number of containers lost overboard each year worldwide. Finally, SARA (Société Anonyme de Raffinage des Antilles) reported a spill of foaming agent in an area of mangrove tree roots. CEDRE / Read more in the CEDRE Newsletter

#### **NETHERLANDS: CONTAINERS LOST OVERBOARD IN THE NORTH SEA**

Editor: This article in the latest issue of the CEDRE Newsletter give some additional information that adds to earlier reports in the ISCO Newsletter.

February 13 - On the night of 1st to 2nd January, as a storm waged, one of the world's largest containerships, the MSC Zoe, lost around 345 containers overboard in the German waters of the North Sea, not far from Borkum. Two of the containers were carrying

potentially hazardous substances: 280 bags each containing 25 kg of organic peroxide powder, and 1,400 kg of lithium ion batteries.

The Netherlands Coastguard and the German authorities took joint command of this incident. A warning was issued to ships travelling through the affected area as to the risk of colliding with containers. The cargo ship was bound for Bremerhaven in Germany. The contents of certain containers washed up on the beaches of the Wadden Islands: car parts, toys, flat-screen televisions, light bulbs, furniture and high density polyethylene, mainly used for manufacturing plastic packaging, in the form of granules. Several bags of peroxide were found north of the Dutch coastline, indicating that the container had burst open. Shoreline clean-up operations began very quickly and were initially carried out by volunteers and the local authorities, but soon taken over by professionals. On the 9th, MSC announced that 1,200 tonnes of debris had been collected.

A coastguard plane conducted overflights above the Wadden Islands to monitor the situation and attempt to locate the containers. From the 6th, ships equipped with sonar searched for the containers lost overboard and recovered them, assisted by other vessels, in mid-January. Some containers had been ripped open and their contents had sunk. A criminal inquiry was opened by the Dutch authorities. The shipping company MSC announced that they would "pay the full costs of the clean-up" and were determined to find every single container lost overboard. ## USA: CALIFORNIA - WHY ARE SEABIRDS COVERED IN OIL WASHING UP ON CENTRAL COAST BEACHES?

February 6 - Large numbers of injured birds with oil on their feathers and legs have been found stranded on Central Coast beaches in the last few weeks, placing high demand on animal emergency clinics like Pacific Wildlife Care in Morro Bay.

The wildlife rehabilitation organization on Wednesday reported an uptick in the number of wildlife treated this year. Of 185 cases, 75 were Clark's grebes or Western grebes — ocean-living diving birds — and 38 of those were contaminated with oil, compared to eight treated for oil in the same time period last year. A total of more than 100 birds contaminated by oil were rescued from Central and Southern California in the last few weeks, according to the Oiled Wildlife Care Network.

Lab results from oiled feathers gathered from clinics suggest the contamination likely came from "seeps," naturally occurring leaks of oil from the ocean floor that are common in the Santa Barbara Channel, particularly during strong storms like those that have been hitting the Central Coast. #### **USA: TEXAS - ENVIRONMENTALISTS TROUBLED BY SIMS BAYOU CHEMICAL SPILL**

February 11 - Environmental organizations are raising an alarm over the potential health impacts of chemicals spilled Feb. 3 into Sims Bayou near Hobby Airport. An estimated 64,000 gallons of jet fuel escaped from a Southwest Airlines-owned fuel storage facility.

Jet A fuel, the type involved in the accident, is a confirmed animal carcinogen with unknown relevance to humans, according to the Chevron Phillips safety sheet on the chemical. One ingredient, naphthalene, is listed as "immediately dangerous to life or health" at concentrations of 250 parts per million. It was not clear what long-term impacts the spill might have on the health of the bayou and nearby residents.

Turtles, toads and over 100 species of birds — including the great blue heron, double-crested cormorant and bald eagle — frequent Sims Bayou, and people fish from its waters. Sims Bayou is known for bass, carp and channel catfish. Chron / Read more

## USA: CALIFORNIA - DOCUMENTARY FOCUSES ON SANTA BARBARA'S COMMUNITY SPIRIT AFTER NATURAL DISASTERS

February 13 - "Better Together" premiered at the Santa Barbara International Film Festival, 50 years after oil from Platform A's blowout reached the shores of Santa Barbara. The catastrophic effects of four million gallons of oil spilling on the ecologically rich Santa Barbara Channel changed Santa Barbara forever and ignited a global shift that resulted in new laws and protections for environmental health.

The 48-minute documentary covers the community's response from that 1969 oil spill all the way to the devastating 2018 Montecito debris flow, and on to community-generated response to a changing climate. "Better Together" covers somber moments of Santa Barbara's history with humor, poetry, and a positive outlook. The voice of Christopher Lloyd (Back to the Future, 1985; Over the Garden Wall, 2014) provides warmth, inspiration, and gravitas. Edhat / Read more

## USA: NAVY DIVERS CLEAR 250,000 GALLONS OF OIL FROM A CAPTURED WWII NAZI SHIP

Hawaii-based Navy divers from Mobile Diving Salvage Unit 1 recently completed the removal of 250,000 gallons of fuel oil from a captured World War II German cruiser that survived two atomic tests in 1946 but capsized and sank later that year at Kwajalein Atoll.

Twenty divers from the unit worked from the USNS Salvor to recover oil from the 697-foot Nazi warship, which lies partially exposed 200 yards offshore from Enubuj Island and just a few miles from the strategically important Kwajalein Island, the largest in the group.

The tiny Army-run island in the Marshall Islands is a U.S. outpost in the South Pacific for space surveillance and object identification, NASA programs and ballistic missile development and testing. It also has a 6,600-foot runway.

"These (oil) recovery efforts will ensure mission capability of the U.S. Army Space and Missile Defense Command/Army Forces Strategic Command's Ronald Reagan Ballistic Missile Defense Test Site on Kwajalein while protecting the sensitive ecosystem within the atoll," the U.S. military said in a news release.

The removal effort began Sept. 1 and was completed Oct. 15 using the Salvor and commercial tanker Humber to transport the removed oil.

After placing nine mooring lines to hold both vessels over the wreck, the dive team drilled holes into each fuel tank using a process called "hot tapping," allowing valves to be installed without fuel leakage, the Navy said.

In 1994 the Navy recommended fuel removal within 30 years, according to the U.S. Fish and Wildlife Service. In 2010 the Republic of the Marshall Islands requested U.S. technical and financial support for the effort, the Navy said.

Kwajalein is increasingly important as China makes inroads in the South Pacific, and the U.S. Indo-Pacific Command in 2016 worked with the Navy to plan for the fuel removal when funding became available.

"Our team's hard work over the last two years preparing for this project and assembling the right combination of equipment and technical expertise enabled our success in this very important mission to protect the pristine waters of Kwajalein Atoll from the risk of catastrophic oil release," Stephanie Bocek, a project manager, said in a Navy release. ## USA: USDOT ANNOUNCES SAFETY RULE TO STRENGTHEN OIL TRAIN SPILL RESPONSE PREPAREDNESS

February 14 - The U.S. Department of Transportation's Pipeline and Hazardous Materials Safety Administration (PHMSA), in coordination with the Federal Railroad Administration (FRA), today issued a final rule that requires railroads to develop and submit Comprehensive Oil Spill Response Plans for route segments traveled by High Hazard Flammable Trains (HHFTs). The rule applies to HHFTs that are transporting petroleum oil in a block of 20 or more loaded tank cars and trains that have a total of 35 loaded petroleum oil tank cars.

"This new rule will make the transport of energy products by railroad safer," said U.S. Secretary of Transportation Elaine L. Chao.

The rule revises the oil spill response plan requirements currently in place to require railroads to establish geographic response zones along various rail routes and ensure that both personnel and equipment are staged and prepared to respond in the event of an accident. Furthermore, railroads are required to identify the qualified individual responsible for each response zone, as well as the organization, personnel, and equipment capable of removing and mitigating a worst-case discharge. The rule also requires rail carriers to provide information about HHFTs to state and tribal emergency response commissions in accordance with the Fixing America's Surface Transportation Act of 2015.

This final rule is effective 180 days after the date of publication in the Federal Register.

#### **USA: FEMA CHIEF BROCK LONG RETIRES**



February 13 - Federal Emergency Management Agency chief Brock Long is leaving the agency he led through a record period of natural disasters — including a widely panned response to a storm that devastated Puerto Rico.

Long was praised for shifting FEMA's focus toward disaster mitigation — spending money to protect vulnerable communities before hurricanes, floods or wildfires occur, to reduce the damage later.

"While this has been the opportunity of the lifetime, it is time for me to go home to my family — my beautiful wife and two incredible boys," Long said in a statement. He said he would leave March 8 and his deputy, Peter Gaynor, would serve as acting administrator. Emergency Management / Read more

#### **ALPHA MERS STOPS 20,000 TONS OF TRASH**





February 11 - AlphaMERS, a corporate member of ISCO has designed and deployed floating barriers at river mouth to stop trash flowing into the sea and bring to the bank using only the natural flow of water, with no boat, fuel or crew. As per latest reports, these barriers have stopped 20,000 tons of trash, weed and plastics from reaching the sea in last one year. 10% of this is noted to be plastics and that is 2 Million Kgs of plastics. While the world is investing millions of dollars in cleaning up the ocean, AlphaMERS is successfully stopping some of the trash and plastics reaching the ocean. The philosophy being, shut the taps before mopping the floor.

After the success of this model, more cities are adopting this methodology and currently this solution is deployed in 10 locations across four municipalities. The company has also designed similar solutions for storm water drains and smaller drains. These have been deployed, tested and have been declared successful by these municipalities.

Interestingly the company designed these barriers to help in dealing with oil spills in Sunderbans in Bangladesh or in various ship breaking yards, where debris or vegetation are typically mixed with oil. While the company did not start marketing the solution to these two segments, the municipalities have found good use for them for trash cleanup.

AlphaMERS has now designed a silt trap for municipality drainage application. This will help change a choked and debris laden municipal drain to one without solid waste on top and no silt transported at bottom, leaving only the drain water to flow freely.

#### UK'S 'EYE IN THE SKY' TO TACKLE OIL SPILLS, ILLEGAL SHIPPING

The UK has unveiled the first images from a new satellite which can see through clouds and image the Earth round the clock to help stop oil spills and illegal shipping.

NovaSAR-1, the first Synthetic Aperture Radar (SAR) satellite made in the UK, can detect oil spills in the oceans, help spot suspicious shipping activity and monitor the effects of deforestation.

"This 'eye in the sky' can capture an image a dozen times wider than the Strait of Dover and the data it provides can help crack problems from illegal shipping to alerting us to damaging pollution that needs to be countered," Sam Gyimah, Science Minister, said.

NovaSAR-1 has 3 imaging modes that create images with higher definition for precision applications including monitoring disasters and deforestation, and it also has a maritime mode and AIS receiver.

The satellite's dedicated maritime mode allows it to monitor an area of ocean 400 km wide. This allows ships to be detected by radar and compared with their ship tracking data, with discrepancies between the two highlighting potentially illegal activity.

#### JOINT INDUSTRY GUIDELINES FOR CARRIAGE OF DVB IN CONTAINERS

January 11 - Joint industry Guidelines for the carriage of Divinylbenzene (DVB) in containers have been published by CINS (the Cargo Incident Notification System), the International Group of P&I Clubs and the TT Club.

DVB is a chemical that is prone to polymerization (a form of self-reaction), and - when shipped in bulk - DVB polymerization can cause heat and flammable gas to be generated. The stowage of containers carrying DVB aboard vessels can therefore present a risk of explosion and fire if they are not properly presented for carriage. In response to a series of polymerization incidents arising from the carriage of DVB by sea, in 2018 the IMO approved changes to the way polymerizing substances, such as DVB, are carried, by means of amendments to the IMDG Code. These changes are contained in amendment 39-18 of the IMDG Code, which will be mandatory from 1 January 2020, but may be applied on a voluntary basis from 1 January 2019.

To ensure the safe carriage of DVB in containers before 1 January 2020 when the amended IMDG Code requirements come into force mandatorily, the joint industry guidelines highlight the practices set out in the IMDG Code amendments and recommend that these are followed now on a voluntary basis.
