A HOLISTIC APPROACH TO MARINE POLLUTION IS REQUIRED TO ACHIEVE UN OCEAN DECADE GOALS

Following the April 2024 UN Ocean Decade Conference in Barcelona, Vidar Helgesen, Executive Secretary of the Intergovernmental Oceanographic Commission and Assistant Director-General of UNESCO, released the Barcelona Statement, calling attention to areas requiring much more intense focus in the second half of the Decade if we wish to meet our goals for a cleaner, healthier, more resilient, productive, predictable, safe, accessible and engaging ocean.

First on the list is to better understand and address the global distribution of marine pollution and its impacts on human health and ecosystems. While significant steps are being taken toward negotiating a global treaty to end plastic pollution, unfortunately ocean pollution doesn't stop at plastics. Many less visible but equally harmful pollutants are in our ocean, ranging from sewage and nutrients to PFAS and pharmaceuticals.

The global focus on plastics offers a vital opportunity to spark a broader effort to end all types of ocean pollution. Achieving the goals of the UN Decade for Ocean Science will require us to take a much more holistic definition of marine pollution, and to adopt a radically new approach to combating it. As we approach the second half of the Decade, now is the time to take action. Back to Blue / Read more

EUROPE: CRASH COURSE ON MANAGING SHARED RIVERS AND WATER RESOURCES

Nearly half of the world's freshwater is shared between at least two or more countries. This Crash Course examines why water cooperation between states is increasingly vital to prevent conflict. Many EU countries rely heavily on water that originates outside their borders. For instance, the Danube flows through nearly a dozen European countries, including Germany, Slovakia, Moldova, and Ukraine. BALTIC: LITHUANIA TAKES OVER THE CHAIRMANSHIP OF HELCOM, PRIORITIZES ENVIRONMENTAL PROTECTION AMID GEOPOLITICAL CHALLENGES

Today, a handover ceremony in Butinge, at the border between Latvia and Lithuania will be held to mark the change of HELCOM Chairmanship. Lithuania will assume the Chairmanship of HELCOM from 1 July 2024 until 30 June 2026, taking over from Latvia. The Chairmanship rotates between Contracting Parties every two years, in alphabetical order.

"It is an honour and a privilege to take over the responsibility of HELCOM Chairmanship in times when protecting the Baltic Sea marine environment must remain high on all agendas", says Mr. Vitalijus Auglys, Head of the Pollution Prevention Policy Group with the Ministry of Environment of the Republic of Lithuania, and the forthcoming Chair of HELCOM. REPORT: ISCO OBSERVER AT THE 18TH MEXICAN PETROLEUM CONGRESS -TAMPICO, 19 TO 22 JUNE 2024

The 18th Mexican Petroleum Congress (https://congresomexicanodelpetroleo.com/) was held in the city of Tampico (state of Tamaulipas) from 19 to 22 June. The birthplace of the Mexican oil industry (first wells in 1904 and the Faja de Oro in 1916), Tampico welcomed thousands of participants from the hydrocarbon exploration and production sector, in an event with more than 140 stands. They were essentially suppliers of all types of oil, maritime and land services of the main Mexican oil company PEMEX and other private sector companies with exploration projects in the country, as well as manufacturers of technology for use in the industry. Mexican federal and state energy and regulatory authorities were also there, allowing interaction with key industry players.

NEWS FROM AROUND THE WORLD

BERMUDA: DRAFT LEGISLATION TO CRACK DOWN ON WATER POLLUTERS

June 28 - New legislation is expected to expand the Government's power to respond to events that threaten Bermuda's waters and increase penalties for offenders. A draft Water Resources Amendment Bill, recently posted online for public consultation, is intended to help the Government crack down on water polluters. The Royal Gazette / Read more

CHINA: THE STATE OF COASTAL AND MARINE ECOSYSTEMS IN CHINA 2023

June 27 - China is located in the eastern Eurasian continent and the west of the Pacific. Its jurisdictional seas cover the temperate, subtropical, tropical climate zones, juxtaposed to the continent with a long coastline and decorated with diverse undersea landforms that are rich in marine biological resources such as coral reefs, seagrass beds, coastal salt marshes, mangrove swamps, estuaries, bays, islands and other ecosystems. They also provide critical habitats for some rare and endangered species such as Harbor Seals, Chinese White Dolphins and Bryde's Whales in the western Pacific Ocean, and key stopover sites along the East Asian-Australasian Flyway. These areas undoubtedly play significant roles in stabilizing the global marine ecological services. PEMSEA / Read the report

June 26 - Participants discussed how Canada's 2030 Nature Strategy's successful and ambitious implementation requires coordinated action and depends on whole-of-society, whole-of-government approaches. They agreed that collaboration between the federal, provincial, and territorial governments; Indigenous organizations and governments; local governments; civil society; academia; and industry is essential. June 26 - Today, the Honourable Steven Guilbeault, Minister of Environment and Climate Change, announced up to \$6 million in funding over the next three years through the Aboriginal Fund for Species at Risk to support 49 conservation projects across Canada. CHILE: DIRECTOR GENERAL OF THE MARITIME TERRITORY AND MERCHANT MARINE PARTICIPATED IN "OCEAN EXPO KOREA 2024"

The visit of the National Maritime Authority took place within the framework of the existing cooperation ties between Chile and South Korea in matters associated with the maritime field, especially in the development of projects and programs related to maritime safety, marine scientific research, postgraduate studies and training of maritime personnel, among others. Gulf of Maine Council Meeting Spotlights Marine Debris Removal

On June 11, the NOAA Marine Debris Program's Northeast Regional Coordinator, Demi Fox, attended a <u>Gulf of Maine Council on the Marine Environment(link is external)</u> meeting in Buzzards Bay, Massachusetts to support a presentation on the final metrics of a Marine Debris Program-funded prevention and removal effort that recently concluded work in Canada and the United States.

USA: NEW APPROACH TO RESTORE CORAL REEFS ON MASS SCALE KICKS OFF IN HAWAI'I

June 25 - 'Āko'ako'a is a recently launched program aiming to restore a 193-kilometer (120-mile) stretch of coral reef along the west

coast of Hawai'i Island — one of the first to attempt restoration at a large scale.

The project will identify individual corals with high thermal tolerance and other high-performance traits, then use them to breed genetically resilient coral larvae for release onto the reefs during natural spawning periods.

'Āko'ako'a is working with partners to reduce other stressors to the reefs, which can help corals be more resilient to rising sea temperatures, and drawing on Hawaiian traditional values of environmental stewardship.

If successful, the project could provide knowledge for how to restore ailing reefs around the world suffering from an onslaught of human-driven thermal stress. Mongabay / Read more

SCIENTISTS DISCOVER WAY TO DESTROY HARMFUL "FOREVER CHEMICALS" IN WATER SUPPLY

New technology could help water utilities remove stubborn PFAS chemicals linked to cancer and other maladies. In 2022, a team at University of California at Riverside discovered that blasting wastewater with special "short-wave" ultraviolet rays causes PFAS chemical bonds to break down without creating harmful byproducts. MARINE FUNGUS CAN BREAK DOWN FLOATING PLASTIC POLLUTION

The plastic-digesting capabilities of the fungus Parengyodontium album could be harnessed to degrade polyethylene, the most abundant type of plastic in the ocean. In lab experiments, Annika Vaksmaa at the Royal Netherlands Institute for Sea Research and her colleagues have shown that the white, thread-like fungus can successfully degrade one of the most pernicious plastics, polyethylene, providing the plastic has first been exposed to UV radiation, such as from sunlight. USA: ARKANSAS - MARTIN MIDSTREAM SAYS CLEANUP UNDERWAY FOR OIL SPILL


June 26 - Martin Midstream Partners L.P. (MMLP) said it is working to mitigate the environmental impact caused by a 2,000-barrel crude oil spill from its transfer pipeline connecting the Sandyland Terminal to the Smackover Refinery in Arkansas. The company said in a media release that it is working actively with the Environmental Protection Agency (EPA), the Arkansas Department of Energy and Environment, and the Arkansas Game and Fish Commission. USA: NORTH DAKOTA - COBRA REPORTS CRUDE OIL, PRODUCED WATER SPILL NEAR MAXBASS

June 27 - Cobra Oil & Gas Corporation reported a produced water and crude oil spill to the North Dakota Department of Environmental Quality. According to a news release, a pipeline break caused the spill near Maxbass on June 24.

USA: CALIFORNIA - UNIFIED COMMAND COMPLETES POLLUTION RESPONSE OF THE CRUISE SHIP AURORA



June 27- A unified command has completed its pollution response to the sunken vessel Aurora, a decommissioned cruise ship, which sank May 22, in Little Potato Slough within the San Joaquin Delta northwest of Stockton.

Over the last several weeks, response contractors, Global Diving and Salvage and subcontractors, successfully refloated the vessel and removed an estimated 21,675 gallons of oily water, 3,193 gallons of hazardous waste, and five 25-yard bins of debris was removed from the vessel. Extensive surveys suggest that no recoverable oil remains onboard. There were no observations of oiled wildlife throughout the response.

ECUADOR: NEW OIL LEAK IN NAPO RIVER

June 28 – An oil leak of undetermined extent has contaminated the Napo River, a major tributary of the Amazon, impacting local communities, according to Petroecuador.

Petroecuador said the leak was caused by ruptured pipes in Block 16, located in the province of Orellana. Intense rainfall washed hydrocarbons, held back by preventive barriers, into the Napo River. Efforts are underway to reinforce these barriers and minimize environmental impact. Communication with affected communities is maintained, although details are lacking. Energy News / Read more
