# TAKING ON THE DARK TANKER FLEET, PART I: FLAG STATE RESPONSIBILITY SHOULD BE FLAG STATE LIABILITY

Want to make the seas safer? Time to put the "Dark Fleet" of aged and unsafe oil smuggling tankers out of business. And the best way to do that is to squeeze not just the ownership and managers of these dangerous and often uninsured vessels, but also the ship registries that support their sanctions-busting activities.

In many countries now, ship registration is a lucrative business, where public rights are appropriated for private gain. Our argument is that the states that register substandard ships should be liable for them, and that the owners and managers of private ship registries should be on the hook for the vessels they certify. Those who register and profit from dark fleet vessels should face liability if those vessels are uninsured and cause pollution.

It is only a matter of time before there is a major oil spill caused by the Dark Fleet, which will cost the unlucky taxpayers of some coastal state billions to remediate beaches and fishing grounds ravaged by thousands of tons of crude oil. Baird Marine / Read more

# ESCAPE AND EVASION: THE DAMAGING ASPECT OF FLAGS OF CONVENIENCE

Editor - Recommended that you also read recent commentary from the highly respected columnist Michael Grey (formerly Editor of Lloyds List)

Creative accountants tell us that there is a subtle difference between avoidance, the legitimate use of every available legal means to minimise one's financial responsibilities to the state, and evasion, which is a polite term for thievery, and thus incurs criminal sanctions.

The long march towards better quality, capable administrations, proper responsibility, and improved maritime safety has been abruptly put into reverse by the emergence of the dark fleet and their improbable flag states. There will be no "implementation" of international rules, the ships may be unsafe and possibly uninsured, their AIS has been extinguished or faked at will, and their class

certificates are null and void. In effect, this is evasion on a global scale - evasion of sanctions, of regulation, of safety and all the other advances brought about by 70 years of regulatory improvement. Baird Marine / Read more

## WESTERN INDIAN OCEAN

A regional agreement aims to save a tropical paradise in trouble - A couple of years ago, in the turquoise waters off the coastal village of Mahébourg in Mauritius, a Japanese oil tanker ran aground. An estimated 1,000 metric tonnes of fuel leaked from the damaged vessel into a pristine lagoon, home to fish, turtles and myriad marine mammals. Mauritius, an island nation in Western Indian Ocean heavily dependent on the sea, declared a state of emergency as oil swamped beaches and killed wildlife. The accident put into stark relief just how fragile the Western Indian Ocean is and the environmental dangers it faces.

Buffeting 10 countries and stretching from eastern South Africa to the Arabian Gulf, the region is home to some 220 million people as well as diverse marine species such as silky sharks and sperm whales. In recent decades, this pristine stretch of tropical ocean that supports some of the most biodiverse ecosystems in the world has come under mounting pressure from climate change, biodiversity loss and pollution and waste. ## **EUROPE**

Degraded ecosystems to be restored across Europe as Nature Restoration Law enters into force - The Regulation on Nature Restoration (Nature Restoration Law) came into effect on Sunday (18 August). Full implementation of the law is crucial to restore the EU's biodiversity and stop further biodiversity loss, to reach climate neutrality by 2050 and adapt to climate change, and to enhance food security for EU citizens. In doing so, the law will support the achievement of other European ambitions, such as water security.

It is also a key instrument to help the EU and its Member States meet international biodiversity commitments under the Kunming-Montreal Global Biodiversity Framework. The law sets in motion a process for continuous and sustained recovery of nature across the EU's land and sea while supporting more sustainable economic development and agricultural production and working hand in hand with the development of renewable energy. As an overall target to be reached at the EU level, Member States will put in place restoration measures in at least 20% of the EU's land areas and 20% of its sea areas by 2030. # CHINA: SHIP-SOURCE POLLUTION WORKSHOP ENHANCES KNOWLEDGE IN SPILL RESPONSE WITH SHANGHAI MARITIME SAFETY ADMINISTRATION

August 16 - TOPF spent time in China with the Shanghai Maritime Safety Administration (MSA), where it hosted a workshop on responding to incidents of ship-source pollution at-sea and on shorelines.



As part of the workshop, ITOPF delivered its interactive table-top spill exercise for Shanghai MSA participants, in which they were tasked with managing the response to a mock scenario pollution event, tackling resource management, applicable clean-up techniques, waste management among other aspects of a response. This included using its Virtual Reality (VR) aerial surveillance application, placing users in a virtual aircraft as they observe a pollution event.

## PHILIPPINES: INCIDENT IN THE PHILIPPINES – TERRA NOVA

August 19 - On 25 July 2024, the MT Terra Nova, carrying 1.4 million litres of industrial fuel, capsized and sank off the coast of Manila, the Philippines. The IOPC Funds understands that as a result, an oil slick was seen to spread from the location of the incident and that measures have been taken to prevent significant impact to the coastline and marine environment.

The Philippines is a 1992 Fund Member State. Therefore, the IOPC Funds has been liaising with the Member State and the ship's insurer, the Steamship Mutual P&I Club, to determine whether the 1992 Civil Liability Convention (1992 CLC) and the 1992 Fund Convention apply to this incident. At this stage, it is confirmed that the vessel is a tanker and that its cargo appears to be persistent oil. As such, the incident will be covered in the first instance by the 1992 CLC. NOAA's Office of Response and Restoration (OR&R) is supporting an oil spill from the tanker *Terranova*, which capsized and sank in Manila Bay, Philippines on July 25, 2024. A Philippine-flagged oil tanker carrying 396,000 gallons of industrial fuel oil, the *Terranova* rests in approximately 130 feet of water off the coast of Bataan.

# T&T SALVAGE - REMOVAL OF CAPSIZED OIL BARGE OFF TOBAGO COMPLETED

The Ministry of Energy and Energy Industries said that the overturned barge "Gulfstream", which had been grounded since February 7, 2024 off the Coast of Cove, Tobago leading to an oil spill, was successfully re-floated on Monday.

The Ministry said re-float operations were conducted under the supervision of a team from an internationally recognized salvage company, T&T Salvage Inc. The Ministry said the team comprised of a senior salvage master, naval architect and a contingent of skilled salvors with the support of the technical staff at the Ministry of Energy and Energy Industries. # **VENEZUELA OIL SPILL (CONTINUED)**

**August 18** - Third Spill From Venezuelan Refinery Contaminates Golfo Triste - The latest release from an aging refinery appears to have contaminated a large swathe of Venezuela's coastal waters and fouled beaches near a well-known nature reserve. The Maritime Executive / Read more

#### New El Palito Refinery Spill - Carabobo State – Venezuela

Once again, and now in the midst of the political chaos in Venezuela, new oil spill has occurred off the coast of this country. On Saturday 17 August (the day of massive demonstrations worldwide against the fraud denounced in the recent Venezuelan elections) satellite images were made public of a huge oil spill of 87 square miles in the area of the Gulf of Triste (located between the states of Falcón and Carabobo), south of the Caribbean Sea (ISCO Newsletter N°951). Without official communication from PDVSA and, for the moment, with few public images of the impacts, it has once again been the reputed Venezuelan marine biologist Eduardo Klein who has published them, assigning the origin of the spill to the El Palito Refinery without providing further details, which endorses his repeated observations and denunciations over several years <a href="https://elestimulo.com/venezuela/2020-08-21/eduardo-klein-la-refineria-el-palito-esta-todo-el-tiempo-derramando-hidrocarburos/">https://elestimulo.com/venezuela/2020-08-21/eduardo-klein-la-refineria-el-palito-esta-todo-el-tiempo-derramando-hidrocarburos/</a>

The complaint indicates that beaches in the Morrocoy National Park, which are very popular with tourists and have sensitive areas with mangroves and ecology that are very sensitive to these impacts, are being affected. **August 20** - Addendum to Carlos' report - 'Almost a week after the denouncement and confirmation of the oil spill at the El Palito Refinery, the silence of the PDVSA authorities responsible for the management of these facilities continues, as well as that of the government authorities of the Maduro regime. NGO reports andimages of the impacts on the coast are increasing, with the beaches of Bocas de Aroa being the most affected, with more than 5 km polluted up to 22 August and growing daily, as there is no containment and recovery at sea. Images have also been shared of contamination on the beaches oTucacas, with threats to the Morrocoy National Park imminent and inevitable in the coming days. Venezuelan NGOs indicate that although the political crisis has paralysed the government, its inaction in the face of this disaster that affects the health and environment of Venezuelans is not justified and, in any case, is a reflection of a regime that has no capacity to manage and respond to this crisis and that is losing credibility and thus control of the country day by day. # SOUTH AFRICA: OIL SPILL CLEAN-UP INTENSIFIES IN SOUTH AFRICA AFTER 'ULTRA GALAXY' WRECK BREAKS APART

August 20 – Authorities are intensifying efforts to clean up oil from the grounded MV Ultra Galaxy cargo vessel on South Africa's west coast after severe weather that cause the wreck to break up further. The South African Maritime Safety Authority (SAMSA) said over 200 personnel are being mobilized to ramp up the clean-up of oil after recent stormy weather further damaged the vessel, causing the release of additional oil. gCaptain / <u>Read more</u>

August 20 - Officials said it is too early to determine how much oil has been released or how much is still in the tanks of the vessel. # TRINIDAD & TOBAGO: OIL SPILL BARGE 'GULFSTREAM' RE-FLOATED, WILL BE TOWED TO TRINIDAD

August 21 - The Ministry of Energy and Energy Industries said that the overturned barge "Gulfstream", which had been grounded since February 7, 2024 off the Coast of Cove, Tobago leading to an oil spill, was successfully re-floated on Monday. The Ministry said re-float operations were conducted under the supervision of a team from an internationally recognized salvage company, T&T Salvage Inc.

The Ministry said the team comprised of a senior salvage master, naval architect and a contingent of skilled salvors with the support of the technical staff at the Ministry of Energy and Energy Industries. The Ministry said the Gulfstream is currently stationed approximately three nautical miles away from its original resting place and is now afloat holding station in waters 60 metres deep off the coast of Cove, secured and supported by tugs. August 21 - T&T launched a containment and remediation effort requesting international assistance. The barge had a capacity of approximately 85,000 barrels. As of April, the teams reported that over 32,000 barrels had been recovered from the barge. A ninemile section of the coastline was also covered with the oil while there had been fears it might also wash toward neighboring countries. The salvage team had to postpone the planned removal operation which had been set for August 5 and 6. It was delayed by the rough surf and conditions created by tropical storm (later hurricane) Ernesto. The Maritime Executive / <u>Read more</u>

# PHILIPPINES: COAST GUARD MAKES PROGRESS ON TANKER WRECK CLEANUP

August 20 - The Philippine Coast Guard and a local salvage contractor are making slow but steady progress on removing oil from the sunken tanker Terra Nova, which went down in severe weather off Bataan last month. Terra Nova sank during Typhoon Gaemi on July 25, and it is resting in the shallow waters of Manila Bay off the town of Limay. The vessel had an estimated 370,000 gallons of petroleum on board, and an unknown quantity of oil spilled out of its holds and into the water. As of August 19, salvor Harbor Star had removed about 11,000 liters of fuel oil from the vessel's tanks using hot-tapping methods, including 2,500 liters on Monday alone.

Salvage operations also continue for two smaller tankers, the Jason Bradley and the Mirola 1, which went down shortly after the Terra Nova. The work currently focuses on plugging tanks and voids to prevent further release of petroleum. The Maritime Executive / Read more

## LIBYA: TWO OIL LEAKS THREATENING MARINE ENVIRONMENT NEAR MISRATA AND BENGHAZI

August 20 - The Libyan Center for Remote Sensing and Space Sciences has announced the recording of new marine pollution in Libyan territorial waters, due to an oil spill from a ship on August 16 off the coast of the city of Misrata, with an area estimated at 25 square kilometers. This is the second leak in just two weeks, on August 6 and 7, a larger oil spill was recorded near the city of Benghazi, with an area estimated at 273.5 square kilometers. # **RED SEA: POTENTIAL FOR AN IMMINENT MAJOR OIL SPILL**

August 22 - The Sounion, which is carrying 150,000 tonnes of crude oil, was first hit by gunfire from two small boats which approached it 77 nautical miles (143km) west of the Yemeni port of Hudaydah, the UK Maritime Trade Operations (UKMTO) office said. Later, the ship was struck by three unidentified projectiles, which sparked a fire and left it without engine power, it added. BBC News / Read more

August 23 - Houthis Set Sounion Tanker Ablaze Causing Potential Environmental Disaster - The Houthis militants released video late on Friday showing explosions aboard the laden Greek tanker Sounion setting the stage for what experts believe will be one of the world's worst environmental disasters. The vessel is fully laden with approximately 150,000 tonnes (more than 900,000 barrels) of crude loaded in Iraq. The Maritime Executive / Read more

August 24 - Delta Tankers has released a statement acknowledging the attack but refrained from providing specific details due to ongoing security concerns. "Delta Tankers is doing everything it can to move the vessel and cargo," the statement read, but the company did not disclose further information on recovery efforts or plans for the damaged tanker. August 25 - The United States warned Saturday of a potential environmental disaster in the Red Sea after Houthi rebels struck an oil tanker off the Yemeni coast. GlobalNation / Read more

# UKRAINE: RUSSIAN KERCH STRAIT FERRY DESTROYED BY FIRE AFTER UKRAINIAN ATTACK

August 22 - Social media is widely showing pictures of a blazing inferno on a strategic Russian railway Ro-Ro ferry while docked today in Kavkaz port in Crimea. Russian media quickly blamed Ukraine which has frequently attacked the port and damaged the same ferry about 12 weeks ago. Black smoking was billowing over the region and government officials on Telegram reported the vessel later sank at its pier. They were working to limit environmental damage. # MALAYSIA: OFFLOADING OF HAFNIA NILE UNDERWAY 35 DAYS AFTER INCIDENT WITH CHINESE VLCC; INCIDENT INVESTIGATION ONGOING

August 23 - The offloading of the naphtha cargo that was aboard the Hafnia Nile when the vessel made contact with the VLCC Ceres I in Malaysian waters approximately five weeks ago is underway. The investigation into the incident also continues being led by Malaysian authorities and monitored by Singapore as the flag state of the product tanker.

A fire ensued aboard both vessels and the Hafnia Nile was abandoned by its crew. A portion of the crew of the Ceres I also left the vessel while others remained behind to assist in the firefight. The fires were extinguished with significant damage to the Hafnia vessel but limited pollution.

The Hafnia Nile was underway near the eastern side of the Singapore Strait when it made contact with the VLCC crude oil tanker Ceres I registered in São Tomé and Príncipe. According to S&P Global, investigators are continuing to explore it as an allision in which the Hafnia Nile struck Ceres I, which was believed to be at anchor. Among the points to be explored, however, is if the vessel was broadcasting an accurate AIS signal and was at anchor as alleged.

The mystery deepened when the Ceres I which was reported to be part of the shadow fleet was missing the following day from the collision scene. Malaysian authorities initially accused the vessel of fleeing but later said the tanker might have drifted because it was without power and initially only being assisted by two smaller tugs. The VLCC was located and directed into an anchorage east of the Malaysian peninsular where it remains.

Reports traced the Ceres I to the Iranian oil trade. It was initially feared it was still laden but images confirmed that it only had ballast when it was struck on July 19. TankerTrackers.com and the NGO UANI both linked the vessel to the operations hiding Iranian oil and reported that it was in a known area used for illicit ship-to-ship transfers. The vessel is also reported to have a history of falsifying its AIS signal location and going dark. Ownership also remains clouded with it being registered likely to a shell company in Hong Kong that has not provided statements since the incident. The Maritime Executive / <u>Read more</u>
