RUSSIA'S SHADOW FLEET IS A TICKING GEOPOLITICAL TIMEBOMB

The shadow fleet poses a significant and rising threat to the environment. The aging and underinsured vessels increase the risk of oil spills, a potential catastrophe for which Russia would likely refuse to pay. The vessels can cause collisions, leak oil, malfunction, or even sink, posing a threat to other ships, water, and marine life. With estimates suggesting over 1,400 ships have defected to the dark side serving Russia, the potential for environmental damage is substantial. For instance, since the beginning of 2022, 230 shadow fleet tankers have transported Russian crude oil through the Danish straits on 741 occasions. Also, a shadow fleet tanker on its way to load crude in Russia collided with another ship in the strait between Denmark and Sweden. Last year, a fully loaded oil tanker lost propulsion and drifted off the Danish island of Langeland for six hours. Recovery after any potential oil spill could take decades. OilPrice.com / Read more

PACIFIC ISLAND NATIONS PROPOSE ECOCIDE BE ADOPTED AS INTERNATIONAL CRIME

Three Pacific island countries have formally requested the International Criminal Court to recognize "ecocide," or mass environmental destruction, as an international crime alongside genocide and war crimes. The proposal, submitted by Vanuatu and co-sponsors Fiji and Samoa on Sept. 9, seeks to amend the ICC's Rome Statute, which currently allows for the prosecution of genocide, war crimes, crimes against humanity, and the crime of aggression. UNCOLLECTED WASTE AND OPEN BURNING LEADING CAUSES OF PLASTIC POLLUTION CRISIS

A new study attempts to shine a light on the enormous scale of uncollected rubbish and open burning of plastic waste in what's described as the first ever

global plastics pollution inventory. University of Leeds researchers used AI to model waste management in more than 50,000 municipalities around the world. Ms. Marsudi will be instrumental in addressing the escalating global water crisis, which is a critical challenge that requires enhanced international cooperation. The appointment also reaffirms the UN's commitment to accelerating multilateral progress towards achieving the water-related Sustainable Development Goals and making transformative changes in the way water is valued, used, and managed. ARCTIC

Oil spills in the ocean: why the Arctic is particularly vulnerable - The Arctic region contains an estimated 13% of the world's undiscovered oil, with one third lying within US territory. The challenge of drilling in the Arctic and mitigating oil spills in the ocean was best illustrated in 2012 when Shell's unsuccessful attempt resulted in the Kulluk drilling rig running aground and needing to be rescued.

However, the effects of climate change on retreating and thinner ice formations may pave the way for economically feasible shipping routes in the Arctic for the first time in modern history. Why are oil spills harder to clean up in the Arctic, how do they damage the environment and what can researchers do to learn more about mitigating spills in this unique climate?

Oil spills in the ocean: the Arctic as a new frontier - Record high temperatures attributed to global warming have once again opened the region to a new era of trans-Arctic shipping. In 2017, the first 300m long commercial LNG oil tanker crossed the Northern Sea Route between Europe and Asia without the protection of an icebreaker. While there has been little research into the effects that oil spills have on the Arctic environment, some studies have shown that the unique climate poses its own challenges, and nature is slower to respond to oil spills than it is in more temperate or tropical conditions.

Oil spills in the ocean: the limitations of oil-eating microbes. - During the clean-up operations of the Exxon Valdez spill in Alaska and Deepwater Horizon in the Gulf of Mexico, only 15% to 25% of oil was successfully removed through mechanical methods, such as mechanical recovery and burning of the spilled oil. The bulk of the clean-up was carried out by oil-eating bacteria in the water. Finance.yahoo.com / Read more

BALTIC

Decreasing trend in detected oil spills in the Baltic Sea continues – Last year, only 32 harmful spills of mineral oil were detected in the Baltic Sea, according to a <u>new HELCOM report</u>. This marks a significant long-term decrease, compared to the 763 pollution occurrences reported in 1989, the first year of aerial surveillance. The decline in detected oil spills, despite increased shipping and more intensive aerial surveillance, is likely due to a higher number of flight hours and the broader use of remote sensing equipment,

such as Side Looking Airborne Radar (SLAR). Enhanced monitoring likely deters ships from making illegal discharges. Satellite surveillance also complements aerial efforts by covering larger areas and improving overall effectiveness of flights.

September 16 - Small European states, such as Denmark, <u>face daily</u> the threat of an environmental Armageddon, as dozens of decrepit, single-hulled, barely insured Russian oil tankers wend their way through the narrowest of straits to the open seas. Often they don't even have <u>local pilots</u> to help them navigate the treacherous waters, let alone proper paperwork, further raising the consequences of a disastrous oil spill. - Request for information from the <u>Maritime Prefecture for the Atlantic</u> on the hazardous nature of a product, in relation to a mooring request made to CENTOPS
- Request from CEPPOL for an opinion on pollution spotted at sea
- Request from the authorities for the Mediterranean coast and the Gard region for an expert opinion based on photos of small slicks of a viscous black substance close to the coast
- Call from the Gendarmerie Maritime's coastal surveillance brigade to validate an idea for a manoeuvre after a small diving vessel sank. Although the vessel had been decontaminated it had 4 cans of diesel on board.
- Discussions with maritime and land authorities following a collision between two vessels off Saint-Nazaire
- Request from the Maritime Prefecture for the Channel and North Sea following pollution off Courseulles-sur-Mer (Calvados)
- Request from the Côtes-d'Armor fire brigade (SDIS 22) following a spill of aluminium sulphate into a watercourse
- Discussions with the maritime and land authorities following a pollution incident in the Somme Bay
- Request from the Seine-Maritime fire brigade (<u>SDIS 76</u>) following pollution in the Seine
- Request from the Manche fire brigade (<u>SDIS 50</u>) following a spill of fire extinguishing powder in a port

INDIA: IOPC FUNDS AT 7TH OIL SPILL INDIA CONFERENCE



September 13 - The IOPC Funds participated in the 7th edition of Oil Spill India, an international conference and exhibition focused on oil spill prevention, preparedness, and response in New Delhi, India, from 11 to 12 September 2024.

IOPC Funds' Director, Mr Gaute Sivertsen, delivered a keynote address during the inaugural session and participated as a panellist in the opening discussion entitled "Horizon Unveiled: Navigating the Outlook & Developments in Global, Regional & National Oil Spill Preparedness and Response". He also joined another session on the topic "Beyond Borders: Strengthening Transboundary Alliances for Unified Oil Spill Response and Protection". IOPC Funds / Read more

Aside from being unnavigable, incessant boat mishaps have made the nation's inland waterway unattractive to passengers and Nigerians, who are expected to see it as an alternative to chaotic land transport. UK: FROM SEPA - OUR SATELLITE SERVICE TAKES CRISIS MANAGEMENT TO NEW FRONTIERS

September 18 - The Scottish Environment Protection Agency unveiled an innovative tool for Scotland's crisis management at the Space-Comm Expo in Glasgow last week. The Satellite Emergency Mapping Service (SEMS) leverages cutting-edge satellite technology to provide real-time, high-resolution data for faster, more efficient responses to emergencies such as floods, wildfires and oil spills. As the only organisation in Scotland able to activate the International Charter: Space and Major Disasters, we provide access to critical satellite imagery, even in areas where ground assessments are impossible. SEMS is the first of its kind, not just in Scotland but in the UK and beyond, supporting future preparedness by using satellite data for scenario modelling and resilience planning. SEPA / Read more

USA: INTERIOR DEPARTMENT INVESTS OVER \$12 MILLION IN ORPHANED WELL CLEAN-UP

Sepptember 15 - The Department of the Interior has announced an investment of over \$12 million, from the president's Investing in American agenda and Biparisan Infrastructure Law, to help four Tribal Nations clean up orphaned oil and gas wells on their lands. The funding addresses the environmental hazards and pollution caused by these wells, which pose risks such as methane leaks, water contamination, and harm to local wildlife. NIO DEVISES NEW TECH TO CONVERT PLASTIC INTO BIODIESEL AND PROTECT ENVIRONMENT

The study on the technology's efficacy has been published in the Elsevier journal 'Bioresource Technology'. "This study mainly focuses on biodegradation of various types of plastics and comprises two major parts - plastic remediation using highly efficient indigenous marine bacteria Pseudomonas mendocina ABF786 and conversion of the by-product carbon dioxide (CO2), obtained from bacterial degradation of plastics to microalgal biodiesel. We have also mapped the whole genome of marine bacteria Pseudomonas mendocina ABF786, representing the plastic-degrading enzyme and genes." Herhaldgoa / Read more

TESTING PLASTIC PELLET RECOVERY EQUIPMENT AT CEDRE'S NEW FACILITIES

In July, Cedre carried out experiments to test different techniques for recovering plastic pellets from the environment, using its new specially designed facilities. PortBin ShoreCleaner has now been tested at Cedre in connection with a larger program they have to collect nurdles / plastic pellets/ mermaid tears. It was tested in both dry and wet conditions. On asphalt, grass, sand, gravel, and pebbles. PortBin ShoreCleaner showed good properties and without particular limitations. It would be great if you share the film/info to anyone you know has problems with nurdles or other small plastics (e.g crumbled styrofoam, pieces of rope or rubber granules from football pitches) on their way into nature,- difficult to pick, or is involved in the problem in another way?

VENEZUELA (CONTINUED)

September 16 - Update received from Carlos Sagrera, Member of ISCO Council and our representative in Latin America "Here news that is well sourced and summaises well the situation with this spill event in Venezuela".

September 14 – "Today I just received this interesting link from the Venezuelan press with information that we can consider objective, given the lack of transparency that exists today in Venezuela, on the current situation of the El Palito refinery spill in the state of Carabobo, which summarises the main issues about causes and impacts, as well as the initialinaction and later ineffective

response of the company PDVSA and their responsible environmental authorities of the Venezuelan government. It answers the following questions:

- Is there an estimate of the possible start date of the spill?
- Is the origin of the spill known?
- Is it known when the oil stopped spilling into the sea?
- Is there an estimate of the magnitude of the event in terms of the surface area of the oil slick and the extent of shoreline affected?
- Is it known whether the spill has affected protected natural areas?
- Is it possible to make any estimate of the impact of the spill?
- Is it possible to state that government agencies are acting effectively to mitigate the impact of the spill?





It notes in its conclusions that: '... the absolute silence and communication blockade hinders the implementation of a much more effective work, with the participation of experts, specialised international organisations and the local communities themselves. It also prevents the health and rights of the people in the affected areas from being safeguarded. Finally, the majority considers that the governmental response has been late, scarce, and outside the national and international standards and norms for action in the face of this type of event, as well as contrary to the international conventions signed by the Venezuelan State'. The OAS has made international complaints about this situation, which has been validated by ISCO's monitoring of this event from Panama (OAS) Representative in Panama https://x.com/almagro_oea2015/status/1830626450338156711?s=48) and the publications of ISCO Newsletter N° 951 & 952 - August 2024 and ISCO Newsletter N° 953 - September 2024.
